Notice is hereby given to all interested members of the public that the Board of Directors (the "Board") of Sunbelt Fresh Water Supply District (the "District") of Harris County, Texas will meet in their regular Bookkeeping and Management Session, open to the public, on **Thursday, August 20, 2026**, at **5:00 p.m.** at the **District Administration Office**, located at **410 W. Gulf Bank Road, Houston, Texas 77037**. The following matters may be considered and acted upon:

3. Minutes of July 16, 2026 regular meeting;
4. District Website Report;
5. Bookkeeper's Report, including:
 - a. financial statements; and
 - b. payment of current bills;
6. Financial Advisor's Report, including:
 - a. review proposed debt service tax rate and operations & maintenance tax rate calculations for Defined Area No. 1;
 - b. authorize publication of recommended tax rate for Defined Area No. 1; and
 - c. schedule date for public hearing to set rate and levy tax for 2026;
7. Operator's Report, including:
 - a. general operations, maintenance and repairs; and
 - b. security cameras owned by East Aldine District located on District property;
8. Administrative Report, including building maintenance and improvements;
9. Director's Ethics Policy, including:
 - a. reimbursement of expenses and payment of fees of office;
 - b. director attendance at meetings and conferences; and
 - c. conflicts of interest and incompatibility;
10. Attorney's Report, including:
 - a. policies and procedures for livestreaming meetings and Director attendance by video conference;
 - b. closing for receipt of funds allocated through the 89th Texas Legislature by Texas Water Development Board; and
 - c. procedures for review of contracts between the District and consultants and vendors.

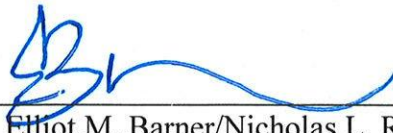
